

USGA RULES will govern all play except as modified by local rules.

LOCAL RULES:

- Ball coming to rest in any cultivated flower bed, free drop within one club length to nearest point of relief no nearer the hole. RULE 33-8a (Appendix 1, 3)
- Coquina shell transition areas are an integral part of the course except for areas designated by black stakes on holes #1, #7, #15 and #16 which are declared cart paths (Immovable Obstructions). Take relief per RULE 24-2. Relief from loose impediments may be taken per RULE 23-1.
- * Sprinkler Heads; Relief may be taken if the sprinkler head is within (2) club lengths of the green and your ball is within (2) club lengths of the sprinkler head. The sprinkler head must be in your line. RULE 33-8a (Appendix 1, 5d)
- Conservation preserve areas are considered "environmentally sensitive" and are defined by red stakes with green tops. Proceed under RULE 26-1, however, entry into and/or play from these areas is prohibited.

SAFETY PROTOCOL:

- **Lightning:** In the event the Thorguard System activates (1) long blast...suspend play and seek shelter (3) short blasts... resume play with caution.
- **Emergencies:** Refer to the *KENSINGTON EMERGENCY PROCEDURES GUIDE*. Please note the location of this guide prior to the beginning of your round.

GENERAL INFORMATION:

- Flag colors: RED-front 1/3, WHITE-Middle 1/3, BLUE-back 1/3.
- Sprinkler heads: RED # - yardage to front, WHITE # - yardage to center, BLUE # - yardage to back.
- Carts rules: Please keep carts on paths at all times when moving toward green. Only 90° crossing permitted.
- Please properly repair ball marks, replace and sand divots, smoothly rake bunkers.
- Post all scores.
- *Pace of play:* If a match fails to keep its pace on the course, and loses more than one clear hole on the players in front, it should invite the match following to pass.
